

TERMS OF CONDITIONS DOUBLE BASS LESSONS 2020/2021

TRIAL LESSON

It is possible to start with a trial lesson of 30 minutes to see if you are interested in taking up the double bass. This trial lesson costs €25,- ex 21% btw and is free of any obligations. After the trial lesson you can choose to start the lessons or to leave it at that. For the trial lesson you will receive an invoice after it took place.

SIGNING UP

You can sign up for lessons via the sign up form on my website, www.robindezeeuw.nl. You can start at any moment in the year. If it turns out that you start halfway in a month, we will adapt the invoice so it matches the number of lessons you took. Your subscription for double bass lessons runs until you cancel it and will not be automatically stopped at the end of the school year.

LESSON OPTIONS

It's recommended to start with a trial lesson to see if it matches and to see if I can offer what you are looking for. If that's the case you can choose between weekly lessons or once every two weeks. It is possible to change your lesson frequency during the season, but this should be in consultation with the teacher, because it affects the weekly planning.

SCHEDULE

Everyone gets his/her own time slot in the lesson schedule. If something changes we can always look for a more suitable time of course.

HOLIDAYS AND PLANNING

The lessons will take place from September until June. Holidays are lesson free weeks, but can be used to catch up on lessons that didn't take place. The official holiday year schedule for secondary school will be followed for the region Netherlands North. See the year planning on the website for more details.

PAYMENT

An invoice will be sent monthly via email at the beginning of every month. The amount is based on the yearly fee for the lessons, but paid in 10 terms (in July and August you will not receive an invoice. Students who choose to have weekly lessons will receive 38 lessons (in 38 weeks) and students who choose biweekly lessons will receive 19 lessons per year. Because of the holidays some months you will receive more lessons than others, but the monthly amount stays the same, since it is based on the total amount divided by 10 months.

BTW

To stimulate cultural education for children the government has decided to make lessons for students under the age of 21 free of taxes. Students of 21 or above will have to pay 21% BTW on top of the lesson fee.

NOT ATTENDING LESSONS

If lessons are not attended by the student they will be charged. However, if the student is not able to come to a lesson and tells the teacher at least 24 hours in advance, the teacher and student will try to find a moment in the lesson free weeks to catch up. This is however no guaranty. When the teacher is unable to attend he will catch up in the lesson free weeks, to meet the required amount of lesson a student signed up for. This will of course be in consultation with the student. When the student is unable to attend the lessons for 3 or more lessons in a row, due to illness or family circumstances, we ask you to let us know so we can look for options of a refund.

CANCELLATION

There is a cancellation period of 1 month. You are never stuck for a whole year, you can cancel at every moment in the year, but you have to finish the month after you have given us notice of cancellation. Please send an email to info@robindezeeuw.nl to confirm your cancellation.
